Dear Marylander:

I am very excited to share with you our 2007 Maryland General Assembly Scorecard. In line with the Maryland League of Conservation Voters' mission to "keep score for the environment," this scorecard includes votes for all members of the General Assembly for the 2007 Legislative Session and is intended to help you evaluate your state legislators' environmental records.

The Maryland League of Conservation Voters (LCV) has been producing the scorecard for over 25 years. To expand our reach and effectiveness, this year we joined forces with Environment Maryland to produce our scorecard. The votes in this scorecard, chosen by the Maryland LCV's Board of Directors in conjunction with the staff of Environment Maryland help to distinguish those legislators who simply call themselves conservationists from those who vote for strong environmental protection when it really counts.

In the 2007 Legislative Session, the Maryland LCV saw some significant victories for our air, land, and water. Working with our colleagues and legislative leaders, we passed the Clean Cars Act, which will reduce tail pipe emissions. We also increased the amount of renewable energy used in Maryland and increased our use of solar energy. In addition, the General Assembly passed the nation's strongest stormwater legislation, which will benefit the Chesapeake Bay and all our waterways.

There were a few disappointments this year, however, most notably the lack of support for the "Green Fund," a bill that would create a dedicated fund for Chesapeake Bay restoration. The legislature also failed to act on the Global Warming Solutions Act, which would have made Maryland a leader in the fight against global warming by significantly reducing our greenhouse gases.

We hope you will find this scorecard useful and use it to hold your elected officials accountable.

SB 332 Green Buildings 13-0—BILL PASSED

Creates the “Maryland Green Building Council,” which will make recommendations on how the state can best build high performance state facilities.

HB 451 Energy Efficient Products

10-3 (No is the correct vote on an unfavorable motion)—BILL FAILED

Would designate a tax holiday for consumers purchasing energy efficient products, which can help Maryland fight pollution and global warming.

HB 76 Solar Tax Credit

13-0 (No is the correct vote on an unfavorable motion)—BILL FAILED

Would reinstate the Solar Energy Tax Credit, a successful program that encourages the use of solar energy.

SB 366 Mercury Switch Removal 7-4—BILL FAILED

Would require the removal and recycling of mercury-containing switches from vehicles, eliminating another sizable source of mercury in Maryland.

SB 498 Expanding Priority Funding Areas 7-4 (Yes is the correct vote on an unfavorable motion)—BILL FAILED

Would weaken smart growth laws in Maryland by allowing too much development in rural areas lacking the infrastructure to support it.

SB 499 Water Appropriation 9-2 (Yes is the correct vote on an unfavorable motion)—BILL FAILED

Would allow municipal corporations to take water from private properties and publicly held lands to accommodate growth that is not smart.

HB 1131 Phosphorus Ban 8-3—BILL PASSED

Bans the sale of dishwashing detergent containing phosphorus, making a major stride in meeting the Chesapeake Bay 2000 agreement goal of a 6 million pound reduction of phosphorus.

HB 488 Electronics Recycling 9-2—BILL PASSED

Establishes a statewide recycling program for electronics, reducing the amount of electronic waste entering landfills.

Amendment was an attempt to weaken the solar energy bill. Fortunately, this provision was stripped off the final version of the bill that was signed by Governor O'Malley.

Senate Floor Votes

1. SB 379 Coastal Bays Dredging

HOUSE BILL PASSED

Yes is the correct vote. Bill failed 20–26.

Bans the harmful practice of hydraulic dredging in the coastal bays.

2. SB 766 Phosphorus Ban

BILL PASSED

Yes is the correct vote. Bill passed 41–5.

Bans the sale of dishwashing detergent containing phosphorus.

3. SB 595 Solar Energy

BILL PASSED

Yes is the correct vote. Bill passed 28–19.

Adds solar energy to the Renewable Portfolio Standard.

4. SB 674 Energy Efficiency Standards

(Pipkin Amendment)

BILL PASSED

No is the correct vote. Amendment failed 15–28.

Sets minimum energy efficiency standards for seven products. This amendment would have significantly weakened the legislation.

5. SB 103 Clean Cars

BILL PASSED

Yes is the correct vote. Bill passed 38–9.

Strengthens Maryland's auto emissions standards.

6. SB 784 Stormwater Management

BILL PASSED

Yes is the correct vote. Bill passed 47–0.

Decreases the amount of stormwater runoff by mandating environmental site design techniques.

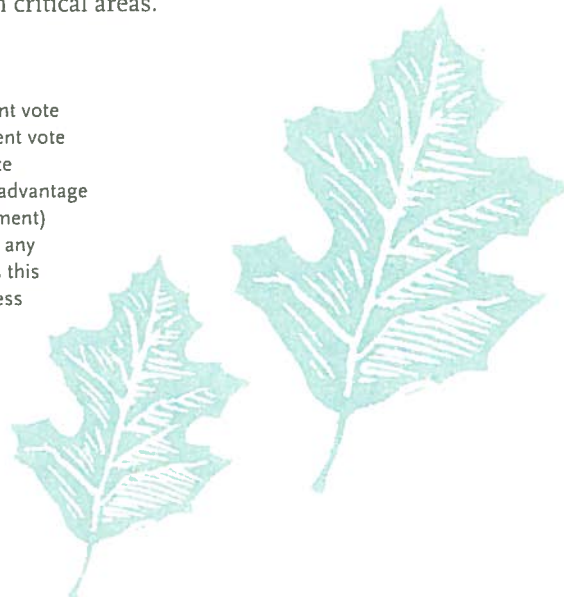
